Just a reminder, WOS's 2019-2020 Season begins with our first rehearsal at the Katonah Village Library on Tuesday evening September 3, 2019 from 7:00 PM to 9:15 PM in preparation for our upcoming Fall Concert on Saturday evening November 23 at 7 PM featuring Bach and Mozart at Presbyterian Church of Mount Kisco.

On Sunday afternoon, December 8 at 3 pm, we will once again present a "Scratch" (sing-along) Messiah in conjunction with the congregation of St. Luke's Episcopal Church in Somers. Our Spring Concert will feature Bach's Mass in B minor on Sunday afternoon May 3, 2020.

Thanks to the generosity of several of our fellow singers, friends, family and other supporters, we were able to finish the season without a deficit. In order to ensure continued success, even as we face ever-increasing expenses, the Board has voted to raise the annual dues by \$25 per semester to \$300 (\$150 half year).
